NOTICE OF 21st ANNUAL GENERAL MEETING

Notice is hereby given that the 21st Annual General Meeting (AGM) of the members of CMM Infraprojects Limited will be held on Tuesday, September 30, 2026 at 11:30 AM through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") to transact the following business:

ORDINARY BUSINESS:

1. To consider and adopt the Audited Financial Statement of company for the financial year ended March 31, 2026 and the Reports of the Board of Directors and Auditors thereon, and in this regard, pass the following resolutions as the Ordinary Resolutions:

"RESOLVED THAT the financial statement of company for the financial year ended March 31, 2026 and the Reports of Board of Directors and Auditors thereon laid before this meeting, be and hereby considered and adopted."

2. To appoint a director in place of Mrs. Shobha Lohia (DIN: 10850211) who retires by rotation at this Annual General Meeting and being eligible offers herself for re-appointment.

Notes:

1. The Company was under Corporate Insolvency Resolution Process ("CIRP") with effect from December 15, 2022 under the provisions of Insolvency and Bankruptcy Code, 2016(IBC") by an Order passed by Hon'ble National Company Law Tribunal. Indore Bench ('NCLT) and Mr. Naveen Khandelwal was appointed as an IRP and thereafter Mr. Satyendra Prasad Khorania was appointed as RP (Resolution Professional). The NCLT vide its order dated November 11, 2024 approved the Resolution Plan submitted by M/s. Effulgence Trading and Services Private Limited and Shree Naivedya Fincom Private Limited under Section 31 of the IBC,2016.

The Resolution Plan is substantially implemented, with share capital restructuring being the only remaining implementation activity. The Company is taking necessary steps to complete the same in accordance with the Resolution Plan and applicable law.

The Company is convening its Annual General Meeting ("AGM") on September 30, 2026 for the financial year ended March 31, 2026.

2. In pursuance of the General Circulars issued by the Ministry of Corporate Affairs (MCA) Circular No. 14/2020 dated April 08, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2022 dated May 05, 2022, Circular No. 02/2024 dated January 13, 2024 and Circular No. 21/2024 dated December 14, 2024, companies have been permitted to hold Annual General Meetings ("AGMs") through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") without the physical presence of Members at a common venue. Accordingly, the **21st Annual General Meeting of the Company** is being convened through VC/OAVM in compliance with the said circulars.
3. In accordance with the Secretarial Standard-2 on General Meetings issued by the Institute of Company Secretaries of India ("ICSI") read with Clarification/ Guidance on applicability of Secretarial Standards -1 and 2 dated April 15, 2020, issued by the ICSI, the proceedings of the AGM shall be deemed to be conducted at the Registered Office of the Company which shall be the deemed venue of the AGM.
4. As the AGM shall be conducted through VC/OAVM, the facility for appointment of Proxy by a Member is not available for this AGM and hence the Proxy Form and Attendance Slip including Route Map are not annexed to this Notice.
5. The register of members and the Share Transfer books of the company will remain closed from Wednesday, 23rd September, 2026 to Tuesday, 29th September, 2026 (both day inclusive).

6. The Board of Directors of the Company has appointed Mr. Rajeev Kumar Jain Shenoy (Membership No. F7981), Proprietor, M/s. Rajeev Kumar Jain, Company Secretaries, as the Scrutinizer for conducting the voting process through electronic means in a fair and transparent manner.
7. The final remote e-voting results of the AGM of the Company shall be declared within 48 hours from the conclusion of the Annual General Meeting. The final results along with the scrutinizers report shall be placed on the Company's website **www.cmminfra.co.in** immediately after the result is declared by the Chairman.
8. In terms of Sections 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 as amended, the Company is providing the e-voting facility to its Members holding shares in physical or dematerialized form, as on the Cut-Off Date, being September 23rd, 2026, to exercise their right to vote by electronic means on any or all of the businesses specified in the accompanying Notice (the "Remote e-voting"). The remote e-voting commences on Sunday, September 27, 2026 at 09.00 a.m. and ends on Tuesday, the September 29, 2026 at 5:00 p.m. Detail of the process and manner of Remote e-voting along with the User ID and Password is being sent to all the Members along with the Notice.
9. In accordance with the provisions of the Act, read with the Rules made thereunder, MCA Circulars and SEBI Circulars, the Notice of the Annual General Meeting along with the Annual Report 2025-26 is being sent only through electronic mode to those Members whose e-mail addresses are registered with the Company/Depositories and whose names appear in the Register of Members of the Company or Register of Beneficial Owners maintained by the Depositories as on Friday, September 04, 2026.
